### B-VARC Board of Directors Meeting Minutes, November 4, 1993

A quorum of the B-VARC Board of Directors met at the Sugar Land Community Center on November 4, 1993. This was the eleventh meeting of the Board of Directors for the 1993 calendar year. The following Board members were in attendance: Betty Wllcox, KAOTEN; Doug Holley, KE5SR; Vincent Orlando, WA5ETS; Sam Wilson, N5CPA; Randy Pollard, AK5G; Victor Richard, N5NAS; Gerry Borg, N5PAW; and Bud King, N5UOG.

President Betty Wilcox, KAØTEN, opened the meeting at 7:30 P.M.

The minutes of the October 7th meeting were submitted by Bud King, N5UOG, and approved unanimously.

Club Treasurer, Sam Wilson, N5CPA, reported a balance of \$3,575.80 in the treasury as of October 31, 1993. The Treasurer's report was approved unanimously.

Vice President, Doug Holley, KE5SR, reported that the Monday night "Code Class" continued to do well. Doug reminded the Board Members to be sure and bring the various items needed for the "Chili Supper" meeting on November 11th.

The Board was notifed that the Wednesday Night "Rag Chew Net" was still holding its own with twelve to fifteen check-in's per session.

In a discussion concerning public service events, the suggestion was made that a training class for communicators be established by knowledgeable B-VARC members.

The purpose of the class would be to provide training for interested members who have not had the opportunity of working various B-VARC sponsored events.

A presentation concerning the location of the annual banquet resulted in the selection of the Houston Engineering & Scientific Society. The date and time for the event will be January 27, 1994, from 6:30 to 9:30 pm. The location of the club is 3121 Buffalo Speedway. The cost of the dinnner will be \$15.00 per person. A cash bar will be available from 6:30 to 7:30. A choice from three entrées can be made at the time the tickets are purchased.

Randy Pollard, AK5G, discussed the mechanics of the election of officers for 1994. Randy also volunteered to take on the position of the Monday night "Net Control" operator for 1994.

Gerry Borg, N5APW, Kelley Hughes, N5ULZ, and others have volunteered to edit and produce the 1994 B-VARC *Bulletin*. This will relieve Vincent Orlando, WA5ETS, of some of the responsibility that he has so generously contributed to B-VARC for the many past years.

Craig Culver, AB5OK, presented information concerning RM-8288, as originated by Ray Adams, N4BAQ, which was submitted to the FCC for consideration. The Board, while taking no action involving B-VARC, did encourage Craig to go to the membership at a regular meeting with the information and suggest that they write the FCC on an individual basis with their comments.

Betty Wilson adjourned the meeting promptly at 8:35 pm.

#### **Dangerous FCC Proposal**

There is a very dangerous proposal by the FCC which will have a detrimental effect on Amateur Radio. The PR Docket 93-267 calls for issuing temporary operating authority to persons who pass their examination for a new Amateur Radio license. This means that a person after passing a no-code Technician license test can go into the local Radio Shack to buy a 2-meter HT and get on the air right away. They will be able to use a temporary call sign instead of waiting the 6-8 weeks for their first call sign to be issued by the FCC.

The FCC proposed a temporary self-issued call sign for those who pass their initial examination and are awaiting their FCC-issued call signs in accordance with the following format: The prefix would be WZ followed by the VEC region of the applicant's address, followed by the applicant's full initials (if the applicant does not have a middle initial, the letter Z would be used). This would be followed by an indicator for whatever class of license the applicant earned. (Novice, no indicator; Technician, KT; General, AG; Advanced, AA; and Extra, AE). For example

my full name is Richard Craig Culver, and am an Extra Class. If I were to pass my initial exam my temporary call sign would be WZ5RCC/AE.

The bad thing about this proposal is that any bootlegger can easily falsify a callsign under the proposed callsign format and there is no way for anyone to verify if he is indeed a legitimate licensee. Currently, any callsign can be checked by calling the FCC or using the Callbook.

Furthermore, there is always a possibility that more than one set of initials and VEC region could exist, thus resulting in duplicate callsigns. For example, suppose that there is a new licensee named James Bobby Jones, with temporary callsign WZ5JBJ/KT. And then maybe another named Jimmy Billy Jackson, WZ5JBJ/KT. The question is "How are we supposed to distinguish James Bobby Jones from Jimmy Billy Jackson, since they both have the same temporary callsign?" Suppose that Jimmy Billy Jackson abused the frequency guidelines. Which of the WZ5JBJ/KT's is Jimmy Billy Jackson?

The FCC PR Docket 93-267 mentions that the FCC has previously adopted the temporary callsign procedure for those awaiting callsigns in the Citizen's Band service. Not so long after the FCC adopted this procedure for CB radio, the FCC deregulated CB radio and the rest is history. This proposal is the first step toward the deregulation of Amateur Radio, and we all saw what happened to CB radio after deregulation.

I am asking you to write to the FCC and tell them not to adopt this proposal. To do this, you must send an original plus four copies before January 10, 1994. Better yet, you should send an original plus nine copies so that each commissioner will get a personal copy. Send these to the Office of the Secretary, Federal Communications Commission, Washington, DC, 20554. If you have any questions, I can be reached at 728-9346.

#### **Dow Chemical 25K Race Communications**

Despite the chilly temperatures, everyone appeared to have an enjoyable time.

The S.H.O.T. (Space Houston On Ten) chapter usually has three or four members who turn in logs for the CW QSO parties, and the chapter actually won a CW QSO party a few years ago. If you like CW, you might want to try one of these low pressure operating events.

#### Low Frequency Solar Eclipse Research by Al Mattis, N5AFV

A solar eclipse will occur in Texas on May 10, 1994, and many LF enthusiasts are preparing to participate in LF propagation research during the event. A total eclipse will occus in the southern portion of the Texas panhandle, and here in Houston, we will experience an eighty percent eclipse of the sun at approximately 1630 UTC. This is the

last solar eclipse that will be visible from the continental United States until the year 2017.

One facet of the research will use non-directional beacons (NDB'S) in the 190 to 526 khz range to look for enhanced propagation in the darkness of the eclipse. LOWFER beacons in the 160 to 190 khz band will also be used. The monitors will record their efforts on audio tape or strip chart recorders so that the results of the monitoring session will be available for detailed study after the eclipse. It is hoped that this project will document eclipse related instabilities in the D layer. Normally, D layer ionization collapses shortly after sunset, but the effects of a solar eclipse on the D layer are not fully known.

Another group of monitors will concentrate on the natural radio frequencies from 0.25 to 10 khz. What effect, if any, the eclipse may have on whistlers and sferics is not known, and this portion of the research may have little chance of documenting eclipse related phenomena.

A third group will focus on the 10-100 khz frequency range. Powerful military transmitters and WWVB (60 khz) will be monitored in an effort to document effects of the eclipse. Previous experience suggests that this frequency range will be affected by the eclipse, and that measurable changes in propagation will probably be documented.

We are fortunate in Texas that we are situated at an ideal location to observe the eclipse. Others who are not so fortunate will have to travel to see the eclipse and participate in the research. Some LOWFERS from outside the eclipse area are even considering setting up temporary beacons along the path of the eclipse. If you are interested in participating in this research, you may wish to write to Michael Mideke who is coordinating the project.
