FCC modifies the Amateur Radio Service rules, eliminating Morse code exam requirements. The new rules become effective at 12:01 AM Eastern Time Friday February 23, 2007. Once the changes are in effect, all Technician licensees -- whether or not they have passed a Morse code examination -- will have "Tech Plus" operating privileges. Technicians will now have all the current VHF/UHF and above frequencies and also will have access to the Novice/Technician Plus frequencies on HF.

## GENERAL CLASS LICENSE CLASSES – Starting March 17.

Ross Lawler, W5HFF and John Chauvin, K5IZO will be teaching license classes again in 2007. The first will be a General Class License Class. With the recent changes in the licensing requirements and the license privileges, it is anticipated that many Technician Licensees will want to upgrade to a General Class License.

The classes will be held for 4 consecutive Saturdays, beginning March 17. Therefore, the final class will end the weekend before the April BVARC testing session. Depending on the final lesson plan, each class is expected to last about 3 – 3 ½ hours. The location is yet to be determined, but will be somewhere in the Southwest Freeway Corridor. More details will be given in the March newsletter. If you are interested, please contact Ross or John. Their contact info is given elsewhere in the newsletter.

There is no charge for this class, but you will need a copy of the ARRL General Class License Manual. These are available at Houston Amateur Radio Supply, Electronic Parts Outlet, sometimes at Fry's and other locations. They can also be bought from Amazon.com or ARRL.

## BVARC Historical Vignettes – Sharpstown Mall Mothers Day Event

Throughout the years, BVARC has been known for its public service events. One of the longest running public service events in the early days of the club was the Mothers Day Event held at Sharpstown Mall prior to Mothers Day each year from 1982 through 1988. Steve Gottlieb WA5OEN chaired the event for the entire 7-year period.

According to minutes from the January 1981 membership meeting, the initial idea for the Mothers Day event was apparently an offshoot of the club's ARRL Field Day activities. There was a discussion in the membership meeting about moving the club's Field Day activity from the Fort Bend County Fair Grounds to a place that would provide more exposure to the public in order to showcase amateur radio.

From the February 1981 newsletter (Vol. 4, No. 2) Stu Lamkin WB5IGG editor:

### AT THE JANUARY MEMBERSHIP MEETING

After a considerable discussion, a motion was lost which would have resulted in the Club's Field Day activities being held in an area shopping mall as a public relations demonstration of Amateur Radio. It was agreed, however, that the idea deserved developing, not as a Field Day activity, but as a special public relations activity of the Club. Henry N5HF will chair a committee to explore the feasibility of the project.

The following year, on May 1, 1982, BVARC's first Sharpstown Center Mothers Day activity was held, and it was very successful.

From the June 1982 newsletter (Vol. 5, No. 6), Stu Lamkin WB5IGG editor:

### REVIEW OF SHARPSTOWN CENTER ACTIVITY ON MAY 1, 1982

Our first effort at a public demonstration of Ham Radio was a success. Along with excellent cooperation from the Center management, we had a super turnout from Club membership. Some of the highlights were as follows:

- 1) Eight new Club members joined.
- 2) Sixty-four pieces of formal traffic were generated.
- 3) The new B-VARC banner was unveiled.
- 4) Many misconceptions about ham radio or HAM vs. CB resolved.
- 5) Much publicity obtained: (a) KPRC-AM and KfKK-FM, (b) Post and Chronicle newspapers, (c) Ft. Bend Advertiser-Advocate newspaper, (d) Sharpstown Center purchased time and space for an electronic sign near the center –but the sign computer cratered!

I want to thank everybody involved in the project for a job well done, but there are some special thanks due (not necessarily in this order):

- 1) The Brazosport ARC group for their active participation and guidance.
- 2) WD5CTQ's printer for donating time and materials for handouts and signs.
- 3) Everyone who loaned us equipment.
- 4) Sharpstown Center Management.
- 5) Madison Electronics for donating handout books and supporting our Club in general.
- 6) Joyce Tabor for publicity in numerous issues of the Ft. Bend Advertiser-Advocate.

The idea behind this event was quite unique – have the public use the amateur radio traffic system to send greetings to their mothers on Mothers Day. The event was usually scheduled a week or two prior to Mothers Day in order to allow sufficient time for delivery of the messages. Club members in Sharpstown Mall forwarded the messages to the Houston Traffic Net who in turn put them into the national traffic system. The club operated from tables set up in the center of the mall near one of the major stairways which put the tables in an area of heavy traffic. Vents in the ceiling above the tables were used to route coaxial cable up to the roof where antennas were erected. Shoppers could see and hear messages being passed, and hear amateur radio operators talking on the HF bands. The event was very popular.

The Mothers Day event did generate a great deal of amateur radio formal message traffic. For example, in the June 1983 B-VARC Bulletin, it is reported that 344 messages were generated at the event held on April 30, 1983. A total of 169 messages were sent from the mall by 2-meters, and 55 messages were sent from the mall by HF. An additional 120 messages were sent by BVARC participants from their home stations after the display at Sharpstown Mall closed. These messages went to 40 different states and 4 foreign countries. In 1984, a total 350 messages were handled. Approximately 15 to 25 BVARC members participated in this event each year, and the Sharpstown activity generated good publicity for both BVARC and amateur radio.

**From the July 1983 B-VARC Bulletin, Stu Lamkin WB5IGG editor:**

OUR PRESIDENT SAYS---

Yesterday, I called the FCC with the intention of ordering a Form 610 I needed, both for myself and for the Club stock. What transpired was a conversation with one of their employees that warmed the cockles of my heart!

When I mentioned that I wanted to get several copies for our club use, she asked me what club I represented. I told her it was B-VARC, to which she replied "I've heard some real nice things about your club."

To make a long story short, after our Mother's Day activity at Sharpstown Center, they received numerous phone calls from folks who-- (1) wanted to thank us for our efforts, and (2) asked for information about our hobby and club. Unfortunately, the FCC did not have any information about B-VARC and the inquiries could not be answered by them.

Well, I basically solved that problem by giving the FCC lady my work phone number and the Club mailing address for future inquiries. She said they get many such calls the year around of the same nature, i.e. Who, Where, When, How, etc.

This all confirms the feeling that we don't toot our own horn enough. Let's kick around ideas on publicizing the Club.

Hope everybody enjoyed Field Day, and that I see y'all at the picnic.

The final Sharpstown Mall Mothers Day Event took place on April 30, 1988. I remember it well because I was one of the club members who went up on the roof to set up antennas. The club was all geared up for the event. We had contacted the ARRL for literature to put out on the table, and we planned to demonstrate state-of-the-art amateur television. Little did we know that this would be our undoing.

The event got underway as usual with no hitches. About an hour into the event Roberts Ricketts N5JKD decided it was time to demonstrate amateur television. A television receiver was set up on one of the tables, and Robert began to walk around the Mall with his camera transmitting a live television picture back to the table. About twenty minutes later Mall Security descended on us. Mall rules forbid the use of television or video cameras in the Mall and our television demonstration was shut down. While mall security and management personnel were at the club tables, the ARRL literature caught their eye. Because some of the ARRL literature included an application for membership in the League, it was determined that we were soliciting money from shoppers, and that was also contrary to mall regulations. As a result, BVARC was not welcome at Sharpstown Mall in future years, and a very successful club activity that show-cased amateur radio to the public came to an end after a long 7-year run.



## 2007 BP MS150 Houston to Austin Bike Tour

### Amateur Radio Volunteer Information

Do you think you can handle communications for emergencies or disasters or medical situations? Can you quickly install your radio equipment into emergency vehicles to help provide communications? If you would like to find out how to be better prepared for emergency communications while helping a worthy cause, then sign up to volunteer to help with communications for the BP MS150 Houston to Austin Bike Tour. Amateur radio communications is the primary communications for the MS150, providing reliable communications for the entire 2-day bike ride from Houston to Austin. Operators are assigned to critical locations along the route as well as being assigned to important individuals and groups during the event. The positions that amateur radio operators are assigned to are:

- **Break points** – Providing communications for supplies and medical problems at break points on the route. – This can be just a few hours to a full day commitment. It is dependent on the location.
- **Medical vehicles** – Operators ride in ambulances and First Responder vehicles for emergency medical communications during the event. – **This is 2 day commitment**
- **MS150 Staff** – Operators ride with MS150 staff to provide communications for important issues and problems during the ride. – **This is 2 day commitment**
- **SAG vehicles** – Provided communications for the SAG drivers who are on the course picking up riders that have mechanical problems or that can no longer ride. – **This is 2 day commitment**
- **Supply Trucks** – Provide communications for the supply trucks so supplies can be routed to the needed locations to deliver supplies and materials. – **This is 2 day commitment**
- **NET Control** – Net controls operations are set up in Houston, Bellville, LaGrange and Austin. There are two NETS running at all times and many operators are needed to cover this very important position. - **This is a 1 or 2 day commitment depending on your location.**
- **Houston Command Post** – The command post interacts with medical incidents, and other problems on the ride. The command post monitors the ride on HF, VHF or UHF amateur bands. Medical vehicles are tracked with APRS units along the entire course and the information is relayed to the course medical coordinator. The command post is set up to receive calls from event personnel and emergency services along the route through an 800 telephone number to coordinate emergency calls and situations. - This can be a one hour commitment to two days. The command post is open from noon Friday to midnight Sunday so many operators are needed to fill this long time period.
- **Motorcycle Marshals** - If you have a motorcycle and an amateur radio license, you can help out with the Motorcycle Marshals that needs volunteers that have a amateur license as well as a motorcycle. With an amateur radio on your motorcycle you can be in contact with the action on the ride, providing valuable information for the safety of the participants. Amateur radio volunteers need a least a 2 Meter/VHF radio (VHF/UHF dual band preferred) that has a minimum of 25 watts output and a gain type magnetic mount antenna (1/4 wave antennas do not work). If assigned to an event vehicle, you must be able to easily transfer between vehicles since assignments do change during the event. Food and sleeping areas (bed linens not provided) are available along the route on Saturday and Sunday by the NMSS organization. A secure parking area will be provided for your vehicle in Houston or Austin if needed. Transportation is available back to Houston for the volunteers that are assigned to event vehicles. Volunteer hours begin at 4:00 am sharp on Saturday morning and will end between 8 and 11 pm on Sunday. There are two informational meetings the week before the ride - one on Monday and one on Wednesday.
