#### DECEMBER MEMBERSHIP MEETING --- IMPORTANT!

Please note that the December meeting will begin at 7 P. M. instead of the usual time. It will be a business meeting only with the following two major items on the agenda:

- 1. Amendment of By-Laws, and
- 2. Election of officers and directors for 1981 (carried over from November meeting.

Wade Eilers WN5TEN, Chairman of the Nominating Committee reported at the November meeting that the Committee had been unable to complete a slate of nominees for officers, each of whom held a General Class or higher license issued by the Federal Communications Commission. He stated the Committee would continue its efforts to complete a slate but believed they would be unsuccessful unless this requirement was lowered. He also stated that he had made a written recommendation under the By-Laws that Article II, Section A which states:

"The officers of the Club shall be: President, Vice-President, Recording Secretary, Corresponding Secretary, Treasurer; each of whom must be a member of the Club and hold a General Class or higher license from the Federal Communications Commission."

be amended to state as follows:

"The officers of the Club shall be: President, Vice-President, Recording Secretary, Corresponding Secretary, and Treasurer; each of whom must be a member of the Club and hold a Technician Class or higher license from the Federal Communications Commission, except that the President must hold a General Class or higher license."

Wade stated that it was the opinion of the Committee that, with this change, the Club would have available the services as officers of very able and willing Club members which it does not have under the provision of this Section as now in effect.

It was discovered that Article V, Section A, setting the number of Club members constituting a quorum for the transaction of matters binding the Club, was worded incorrectly in the By-Laws adopted by the Club at the September meeting, and that such wording did not reflect the intent to set a reasonable and practicable quorum. Stu Lamkin WB5IGG, Chairman of the By-Laws Committee has made a written recomendation under the By-Laws that this Section which states:

"A quorum shall be deemed to be more than half (50% + 1 or more) of Club members who are present at a membership meeting either in person or by proxy."

be amended to state as follows:

"A quorum shall be deemed to be 15 or 25% of the Club's total membership, whichever is greater".

This will be one of the most important meetings of the Club and each member is urged to make a special effort to be present. It is hoped the meeting can start promptly at 7 P.M., and that it can adjourn in thirty to forty-five minutes.

#### PRESIDENT'S MESSAGE

This is the last time I will be writing to you as president of BVARC. On the whole I believe we had a fairly successful year. A number of new things were introduced which were well received by the membership and some things remain to be completed or finalized. I hope to have the privilege of carrying these to a successful conclusion if authorized to do so by the new president.

During the year I have tried to guide the Club in the direction I thought was best for the membership. This has not always been 100% agreeable to all members but a president runs an organization not a popularity contest. Fortunately, to my knowledge, we have had no serious disputes. I can say that everyone attending meetings has been fully informed of what is going cn, witness the gripes about long meetings, and nothing has been done without the full knowledge of the membership.

I am very disappointed about one thing, however. An organization as healthy as BVARC should have a high level of participation in all activities of the Club. This is not the case and with an all time high of 50 members everything still seems to be done by a handfull of people. I was appalled that the nominating committee could not come up with a slate when over 60% of the membership qualifies to hold office under the present Bylaws and the Bylaws have to be changed in order to elect officers and a Board. This is difficult to believe.

I strongly urge <u>ALL</u> members to take another look at the Club and ask themselves, "Where can I fit in and what can I do to help make this Club the best in the Houston area?". I think the Club is well on it's way and nothing but indifference can stop it.




- 1. Affiliated clubs can receive lists of ARRL full members in the club area once each year for membership solicitation purposes, or ARRL associate members for class solicitation.
- 2. Special bulletins from ARRL to affiliated clubs are mailed at frequent intervals containing everything we can find that is of interest to the typical ham group. Examples: Ideas for contests, programs and other club activities, new training aids available through your headquarters, discussion of Field Day, class ideas, what other clubs are doing.
- 3. The affiliated organization retains \$1.50 of each membership entry sent to ARRL by an officer; it helps the treasury.
- 4. Occasional publicity drafts are mailed out to affiliates only. Examples are PR releases on National Radio Week/Field Day. A complete publicity kit is available so affiliates may make their own drafts, the best kind as far as local papers are concerned.
- 5. Affiliated groups are the first called upon to sponsor Official League conventions.
- 6. Affiliation requires approval of elected directors, who can usually be prevailed upon to visit at meetings. Affiliated clubs also get first chance on visits from headquarters staffers who happen to be traveling in the area.
- 7. National distinction and recognition is afforded by displaying the ARRL emblem on organizational posters, stationery, etc.
- 8. Most training aids material is available <u>first</u> to affiliates. Visual aids include sound films and slide sets. Taped programs and quizzes are also available. Most training aids require booking at least a month in advance.
- 9. Only affiliated clubs are eligible for participation in the gavel competitions in the DX Contest, the November Sweepstakes and the V.H.F. Sweepstakes.
- 10. Affiliated clubs are eligible to receive special achievement awards for holding license classes, Amateur Radio promotion, etc.
- 11. Affiliated clubs can donate the complete set of ARRL publications to local library at approximately one half cost. The 3 Tommy Rockford high school level books on Amateur Radio are available to affiliated clubs for \$1.00 postage, to be sent to libraries.

The cost to the club: zero! Simply return an annual report to ARRL and keep up the 51% ARRL member requirement. Write the Club and Training Department of the ARRL for further details on any of these benefits.

# SAFETY (Cont.)

After all, electricity isn't proud -- it would just as soon kill a ham as a CBer!



• Take care when installing CB and TV antennas. They are one of the major causes of home electrocution. Keep at least 1-1/2 times in the control of between your antenna and any power has a control ones like those running along the rear of most homes in our service area carry 12,000 volts or more and they are not insulated. If you have any doubt about your ability to install an antenna safely, call a professional contractor to do the job for you.

- For salety's sake we've placed our lines out of reach, high off the ground or underground. But some trees do grow near overhead lines. Alert your children to look carefully for electric lines before they start to climb and do the same yourself when tree trimming.
- When using a metal ladder, watch where you place it. Never position it near electric wires. Metal ladders are excellent conductors of electricity.
- Some home electric supply lines are underground. The large steel transformer boxes serving these lines at intervals throughout the neighborhood are safe when closed and locked. If one is open or damaged, stay clear, report it immediately to the Light Company and warn others to keep away until we can get there.
- Keep electric appliances in good condition. If you get a slight shock when handling any appliance or tool, have a qualified serviceman repair it before using it again.
- Unplug all electrical appliances before repairing, oiling, cleaning or adjusting them.
- Don't touch a person who is electrically shocked until you have turned off the current or disconnected the plug.
