Since the first article was written, I have heard about a couple of other changes.

opportunity to advertise our club in the upcoming issue of the ARRL Repeater Directory and become better known throughout the amateur community.

The recent Westlink Report warns the amateur community that the Cellular Telephone Industry is lobbying our Congress to pass a new law which would limit the frequency bands that woud be available for the public to legally listen to.

The new bill, called "The Electronics Privacy Act of 1985", HR 3378 and Senate S-1667, is asking that all autopatch telephone calls be included under the new "anti-evesdropping" law and that separate sub-bands be created for ham autopatch operations.

Please write your Congressmen and Senators immediately and let them know that the Cellular Telephone Lobby is not the representative of the Amateur Radio Operators in the United States and that we want no part of their organization or their protection. We live by the FCC Communications Act of 1934 and please ask your representatives to kill both these bills to keep us free of commercial interests.

Please write your Congressman and Senator today! If you need their addresses, call Harold ND5F, at 464-9044 or George ND5E,, at 663-6443. We also have some guidelines to help you compose your response.

MORE FROM THE OLD TIMER (From RAGS REVIEW, Rochester NY, WA2PUU, Editor)

Up until recently, I believed that the only real threat to the survival of amateur radio came from outside competition. Such as big corporations and governmental institutions greedy for new spectrum space, and so on. Well, dear friends, I am changing my mind. The big threat is from the inside" From our own fellow amateurs.

After many hours of listening to the Mexico City earthquake nets, and more recently, the Hurricane Gloria nets, I am convinced that we have a severe and growing cancer in our vitals.

The jamming of nets handling emergency trffic was unbelievable. Finding a net not subject to harrassment was almost impossible. The continuing discourteous behavior and deliberate interference are surely not compatible with the noble objectives of amateur radio or, indeed, the federal law.

What is happening to our amateur radio service? Is the continual push for ever greater growth in numbers of hams responsible for the decrease in character and honor? Is the ever-decreasing ability of our government to enforce its laws the reason? Is the Judiciary really completely out-to-lunch?

What can we hams do about this horrifying situation? I keep tired of hearing --- , "Just hang in there. Things will get better."

The present state of ham radio reminds me of a desperate man sliding off a slate cliff, his fingernails scratching for a handhold; flipping over the edge and disappearing with a scream into silence eternal.
